IN WEST AFRICA GLOBAL PARTNERS IN HOPE IS WORKING ALONGSIDE ITS PARTNER IN MALI, C.P.A.M., TO CONTINUE TO PROVIDE TRAINING AND SUPPORT FOR NINE EXISTING HEALTH CENTERS AND CLEAN WATER WELLS PREVIOUSLY ESTABLISHED BY GLOBAL PARTNETS IN HOPE IN OUTPOST VILLAGES IN THE BAKO REGION OF MALI. CURRENTLY THESE HEALTH CENTERS SERVE A POPULATION OF APPROXIMATELY 90,000 PEOPLE.

THE WORK OF GLOBAL PARTNERS IN HOPE HAS ALSO EXPANDED IN WEST AFRICA TO INCLUDE THE COUNTRY OF TOGO, IN PARTNERSHIP WITH A LOCAL NGO, COMPASSION. THE OBJECTIVE IN TOGO IS TO ESTABLISH A CENTRALIZED MEDICAL FACILITY ALONG WITH FIVE OUTPOST HEALTH CENTERS. EACH HOSTING ITS OWN CLEAN WATER WELL AND SOLAR ENERGY SYSTEM, IN THE ZIO DISTRICT OF TOGO.
